The Organiser 1000 MIGLIA s.r.l. based in Brescia - Via Enzo Ferrari 4/6 - Brescia, holder of the licence n. 356540, delivered by ACI SPORT, currently valid, announce and organise, as from ~~Sunday 10 to Saturday 16 May~~ **Monday 19 to Sunday 25 October 2020** a Classic Regularity Competition for Historical Cars, Grand Event, to be known as:

**1000 MIGLIA 2020****Article 5 - COMPETITORS, DRIVERS AND CARS ALLOWED**

**5.1.8** The substitution of a competitor after the close of entries, is not permitted.

~~Only one~~ crew member may be substituted:

- with the authorisation of the Organiser, up to the start of administrative checks;
- with the authorisation of the Stewards, from the start of checks until publication of list of admitted competitors and crews and of the accepted competition cars.

The substitution of two members of the crew is subject to the approval of the Organiser, in accordance with the ASN of the organiser.

Until 11:59 p.m. on ~~16 April 2020~~ *Friday July 31<sup>st</sup> 2020* the first substitution of ~~a~~ *both* crew members or the inclusion of ~~a~~ names not previously notified, are free of charge. *From Saturday August 1<sup>st</sup> 2020* all subsequent replacement of a team member will be charged and amount of € 366,00 (equal to € 300,00 + VAT) as administration fees. If payment is not made, the request for substitution will not be considered valid.

*Any request received after Thursday September 10th 2020 will not guarantee the visibility of the names in the official race publications.*

~~From 17 April 2020, each replacement of a member of the team or insertion of driver not initially stated at registration will be charged an amount of € 366,00 (amounting to € 300,00 + VAT) as administration fees.~~

~~It will not be possible to replace both crew members if the car has already been replaced. This provision does not apply to the entries of "Team Sponsor" cars/crews.~~

## 5.4.8 REPLACEMENT OF A COMPETITION CAR

### 5.4.8.1 Conditions for substitution

Until 23:59 on ~~Thursday 16 April~~ *Friday 31 July 2020*, the replacement of a car accepted or inserted in the waiting list is allowed. *From Saturday August 1<sup>st</sup> 2020 until Thursday September 10<sup>th</sup> 2020 the replacement of a car will be granted for a fee according to the following art. 5.4.8.2.* A car accepted or placed on the waiting list can be replaced, with the approval of the organizer, only with another car that meets all the requirements of these SR ~~and a coefficient of merit equal to or greater than that of the car replaced according to what is contained in the Table of coefficients 1000 Miglia 1927-1957 (see Article 5.4.9 of these SR).~~ Once the aforementioned deadline has passed, it will not be possible in any way to replace a car accepted or inserted in a waiting list.

~~It will not be possible to replace cars related to entries that have not been accepted. This provision does not apply to the entries of "Sponsor Team" cars.~~

~~It will not be possible to replace the car if both crew members have already been replaced. This provision does not apply to the entries of "Sponsor Team" cars.~~

**7.9.1 REFUND OF THE ENTRY FEE FOR WITHDRAWAL OF AN ENTERED CAR**

The refund (if due) of the entry fee in the case of withdrawal by a competitor will only come about in compliance with what is stated below:

- if the request for withdrawal of entry is notified by 23h59 (GMT+1) on ~~Friday 24 April~~ Thursday 28 August 2020, the entry fee will be refunded, amounting to 50% + VAT;
- if the request for withdrawal of entry is notified after 24h00 (GMT+1) on ~~Friday 24 April~~ Thursday 28 August, the entry fee will be not refunded

In any event, the entry fee will be refunded within 60 days from the date of notification of the withdrawal.

**7.11.2 CLOSURE OF THE "WAITING LIST"**

**7.11.4 SCRUTINEERING AT ADMINISTRATIVE CHECKS**

Albeit without any guarantee of participating, competitors on the "Waiting list" will be able to be present at administrative checks on ~~Wednesday 13 May~~ Thursday 22 October 2020, from 07:30 to 08:30. After having entered, they have the possibility of being admitted to the competition after scrutineering, at the unquestionable judgement and discretion of the organiser.

If the competitors accepted from the waiting list had paid the entry fee of the gold package, the partial refund of the security deposit will take place within 60 days following the date of withdrawal and in any case no later than Monday ~~29<sup>th</sup> June~~ 30 November 2020.

**7.11.7 REFUND OF DEPOSIT FOR VEHICLES ON THE "WAITING LIST"**

If owed, the deposit fee will be refunded within 60 days from the date of notification of the withdrawal, and nonetheless within and no later than Monday ~~29<sup>th</sup> June~~ 30 November 2020.

It remains firm that competitors who do not withdraw and are not selected from the "Waiting List" have the right to be refunded in full for the amount paid by bank transfer or accredited on their credit card by Monday ~~29<sup>th</sup> June~~ 30 November 2020.

Competitors entered in the waiting list are also given the right to use the guarantee deposit withheld by 1000 Miglia Srl for the 2020 edition as a guarantee deposit for the 2021 edition of the 1000 Miglia event, therefore 1000 Miglia srl will not provide for reimbursement by November 30th 2020.
