Until 11:59 p.m. on Friday ~~July 31st~~ **September 18th 2020** the first substitution of ~~a~~ **both** crew members or the inclusion of ~~a~~ names not previously notified, are free of charge. From Saturday ~~August 1st~~ **September 19th 2020** all replacement of a team member will be charged and amount of € 366,00 (equal to € 300,00 + VAT) as administration fees. If payment is not made, the request for substitution will not be considered valid.

Any request received after ~~Thursday~~ **Friday September 18th 2020** will not guarantee the visibility of the names in the official race publications.

5.4.8 REPLACEMENT OF A COMPETITION CAR

5.4.8.1 Conditions for substitution

Until 23:59 on Friday ~~31 July~~ *September 18th* 2020, the replacement of a car accepted or inserted in the waiting list is allowed. ~~From Saturday August 1st 2020 until Thursday September 10th 2020 the replacement of a car will be granted for a fee according to the following art. 5.4.8.2.~~ A car accepted or placed on the waiting list can be replaced, with the approval of the organizer, only with another car that meets all the requirements of these SR. Once the aforementioned deadline has passed, it will not be possible in any way to replace a car accepted or inserted in a waiting list.

ARTICLE 7 – ENTRIES *(Cross out the parts to cancel and in bold italics the changes made)*

7.9.1 REFUND OF THE ENTRY FEE FOR WITHDRAWAL OF AN ENTERED CAR

The refund (if due) of the entry fee in the case of withdrawal by a competitor will only come about in compliance with what is stated below:

- a) if the request for withdrawal of entry is notified by 23h59 (GMT+1) on ~~Thursday 28 August~~ *Friday September 18th* 2020, the entry fee will be refunded, amounting to 50% + VAT;
- b) if the request for withdrawal of entry is notified after 24h00 (GMT+1) on ~~Thursday 28 August~~ *Friday September 18th*, the entry fee will be not refunded

In any event, the entry fee will be refunded within 60 days from the date of notification of the withdrawal.
