### Self-declaration – COVID-19 PRECAUTIONARY MEASURES

#### DECLARE

- to be aware of the measures to contain the contagion currently in force
- to not be currently subject to the measures of quarantine or of fiduciary home isolation
- to have not had contacts in the last 14 days with subjects who tested positive for COVID-19 or come from risk areas according to WHO guidelines
- not to show any sign or symptom of altered health or general well-being, and to be aware of the obligation to stay at home in the presence of fever (higher than 37.5°C) or other flu symptoms
- to agree to be subject to body temperature control
- to have complied with the travel regulations indicated on the Italian Ministry of Health website, section "Covid-19 – Travelers" ("Covid-19 – Viaggiatori")
- to undertake to comply with all the provisions of the relevant Authorities and 1000 Miglia for accessing to, and staying in, the event areas
- to undertake to wear, from the moment of their delivery, the personal bracelet and access pass issued by 1000 Miglia for accessing the event areas, and to be aware that they are strictly personal and not transferable to third parties
- to be aware and accept the fact of not being permitted to enter into, or remain in, the event areas, and to have to declare it promptly, if even after the entrance any condition of danger occurs, pursuant to which the Authority's measures requires to inform the family doctor and the Health Authority (symptoms of flu, temperature, provenance from areas risk or contact with a person tested positive to the COVID-19 virus in the previous 14 days, etc.)
- to have read the attached privacy policy

#### NOTE THAT

- access to the event areas is conditioned to compliance with protocols in force and the available capacity of the same
- body temperature may be measured at each access to the event areas as well as within the areas themselves
- if my body temperature is higher than 37.5°C, my access and stay in the event areas will not be allowed

#### UNDERTAKES

in the event of any change relating to my state of health and/or any of the situations contemplated above that may occur from the execution of this document and until the end of the event activities:

- to immediately communicate such circumstances to 1000 Miglia, and in particular to the COVID Manager covidmanager@1000miglia.it
- to refrain from accessing the event areas and/or from taking part in the event activities
- to interrupt my participation to any activity in progress, according to the instructions possibly provided by the COVID Manager and in any case to take all necessary and/or appropriate initiatives in order to prevent and/or limit to the extent possible any risk of spread of COVID-19, without prejudice to compliance with the legislation and Authorities' provisions from time to time applicable.

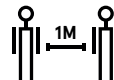

## Privacy notice for the processing of personal data, pursuant to art. 13 of the GDPR

### Self-declaration – COVID-19 PRECAUTIONARY MEASURES

#### PREAMBLE

Given the worsening of the emergency linked to the spread of the COVID-19 disease, companies, foundations and cooperatives have been forced to adopt certain measures aimed at contrasting and containing the same. The adoption of these measures by data controllers (which may include real-time detection of body temperature or filling of questionnaires or "self-declaration" forms) involves processing of personal data pursuant to art. 4, no. 2) GDPR, pursuant to which the data subject has the right to receive specific information.

To this aim, and pursuant to art. 13 GDPR, we provide you with the following information:

#### 1. Data Controller

1000 Miglia S.r.l. (hereinafter the Company), with registered office in via Enzo Ferrari no. 4/6 - 25134 Brescia, Italy, as the Data Controller, wishes to inform you that EU Regulation no. 2016/679 (hereinafter GDPR) governs the protection of personal data in the context of the processing of the same.

The Company processes personal data based on principles of correctness, lawfulness, transparency and necessity, thus protecting your rights.

#### 2. Subject of the processing activity

The processing relates to your personal details (e.g. name, surname, date of birth, residency) and to your health data (e.g. data relating to body temperature and/or if you are subject to quarantine for COVID-19).

The provision of personal data is optional, but if you refuse to provide your data access will not be allowed.

#### 3. Purpose and legal basis of the processing

The processing of personal data is exclusively aimed at the implementation of the measures and protocols of prevention and protection against the COVID-19 disease adopted by the Company, also in accordance with the provisions drawn up by the Italian Ministry of Health and the Italian Health Institute (Istituto Superiore della Sanità). The processing is based on the following legal basis:

- Italian Legislative Decree no. 81/2008 (article 6, paragraph 1, letter c) GDPR)
- Decree of the Italian Prime Minister (Decreto del Presidente del Consiglio dei Ministri) dated April 26, 2020 and subsequent Decrees of the Italian Prime Minister (Article 6, paragraph 1, letter c) GDPR)
- Ordinance of the Lombardy Region (Ordinanza della Regione Lombardia) no. 604 of September 10, 2020
- Law Decree no. 6 of February 23, 2020, art. 1, letter h (article 6 paragraph 1, letter c) GDPR)
- Shared protocol for regulating measures to fight and contain the spread of the Covid-19 virus in workplaces dated March 14, 2020 and subsequent amendments and additions (Article 6, paragraph 1, letter c) GDPR)
- Art. 9, paragraph 2, letter g) GDPR.

#### 4. Processing methods and data retention

Personal data are processed pursuant to art. 4, n. 2) GDPR by means of the following operations: collection, storage, consultation, cancellation and deletion of personal data.

The body temperature will be recorded only if the 37.5°C threshold is exceeded and for the sole purpose of documenting the reasons for the denial of access to the event areas.

The Company undertakes to adopt all technical and organizational measures appropriate to the risk, aimed at ensuring the confidentiality and dignity of data subjects.

Your personal data will be processed on paper and/or electronically and, starting from their collection, they will be retained for a reasonable period in light of the purposes of the processing activities as indicated in clause 3 and, in any case, until the end of the emergency state.

#### 5. Communication and transfer of personal data

Your personal data will not be disclosed or communicated to third parties save if specifically required by the law (e.g. in case of request by the Italian Health Authority for tracing any close contact of a data subject tested positive for COVID-19).

Personal data will be processed exclusively by the following categories of subjects, in charge of the processing activities and adequately instructed by the Data Controller:

- Employer of the Company (Datore di lavoro della Società);
- Person responsible for the prevention and protection service (Responsabile del Servizio di Prevenzione e Protezione, RSPP);
- Company doctor;
- Other employees of the Company who operate as persons authorized to the processing activity due to their role and/or task performed in the management of the emergency.

#### 6. Rights of data subjects

Without prejudice to specific and mandatory legal obligations related to the emergency management, data subjects may exercise all rights referred to in Articles 15, 16, 17, 18, 20, 21 and 77 GDPR with regard to the processed data.

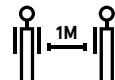
