- Entries opened on **19<sup>th</sup> November 2020**;
- Entries will close on **18<sup>th</sup> January**, **Sponsor** entries will be admitted until **29<sup>th</sup> January 2021**;
- Withdrawal of a Competitor list by **9<sup>th</sup> March 2021**.

## Withdrawal of a Competitor Application

FROM: Opening date of entries → TO: Closing date of entries

Return of the **amount paid net of deduction of € 150.00** plus VAT.

FROM: The day following the closing date for entries  
→ TO: Publication of the accepted cars

Return of the amount paid net of a **penalty of € 1,000.00** (not subject to VAT pursuant to article 15(1) of Presidential Decree 633/72).

FROM: The day following the publication of accepted cars  
→ TO: Wednesday 31<sup>st</sup> March 2021

Return of the amount paid net of a deduction **equal to 25% of amount paid** plus VAT.

FROM: Thursday 1<sup>st</sup> April → TO: Thursday 15<sup>th</sup> April

Return of the amount paid net of a deduction **equal to 50% of the amount paid** plus VAT.

FROM: Friday 16<sup>th</sup> April → TO: The race

The entry fee shall not be refunded.

## Withdrawal of a competitor for SPECIAL CASES (\*)

Until 9<sup>th</sup> April

- A. Return of the **amount paid net of a deduction of € 150.00** plus VAT.
- B. Transfer the fee paid to the next edition of the race, without prejudice to any economic integration in the event of an increase in the entry fee and without prejudice to the need to re-enter for the race.

FROM: Thursday 10<sup>th</sup> April → TO: Wednesday 21<sup>st</sup> April

Return of the **amount paid net of a deduction equal to 10% of the amount paid** plus VAT.

FROM: Thursday 22<sup>nd</sup> April → TO: Friday 30<sup>th</sup> April

Return of the **amount paid net of a deduction equal to 50% of the amount paid** plus VAT.

FROM: Saturday 1<sup>st</sup> May → TO: The race

The entry fee shall not be refunded.

(\*) **SPECIAL CASES** include only people residing:

1. in countries that are blocked from entering Italy, by order of the Italian authorities or the country in relation to the COVID-19 health emergency;
2. in countries from which exit is blocked by order of the authorities of the same country in relation to the COVID-19 health emergency;
3. on Italian territory, in an area (e.g., Region, Province, Municipality) from which exit is blocked by order of the Italian authorities in relation to the COVID-19 health emergency;

**For the purposes of the application of the provisions set forth in this article, person means alternatively:**

- A. the competitor who is part of a Team;
- B. the owner (provided he is a natural person) of the vehicle if he is part of the crew;
- C. both the drivers indicated during the entry phase.

## Cancellation or suspension of the event due to the Covid-19 pandemic and force majeure

FROM: Opening date of entries → TO: Closing date of entries

The amount paid will be **refunded in full to the competitor**.

FROM: The day following the closing date of entries → TO: Wednesday 31<sup>st</sup> March

Return of the **amount paid net of a deduction of € 250.00** plus VAT.

FROM: Thursday 1<sup>st</sup> April → TO: Wednesday 21<sup>st</sup> April

Return of the **amount paid net of a deduction equal to 10% of the amount paid** plus VAT.

FROM: Thursday 22<sup>nd</sup> April → TO: Friday 30<sup>th</sup> April

Return of the **amount paid net of a deduction equal to 20% of the amount paid** plus VAT.

FROM: Saturday 1<sup>st</sup> May → TO: Sunday 9<sup>th</sup> May

Return of the **amount paid net of a deduction equal to 50% of the amount paid** plus VAT.

FROM: Monday 10<sup>th</sup> May → TO: The race

The entry fee shall not be refunded.
