

1000 Miglia Experience 2021 will be held from **16th to 19th June 2021**.

- Entries opened on **29th March 2021**;
- Entries will close on **30th April 2021**;
- Publication of the accepted cars by **7th May 2021**.

Withdrawal of a Competitor Application

FROM: Opening date for entries → **TO:** Closing date for entries

The fee paid as deposit by the Competitor shall be entirely refunded to the latter, net of administrative charges in the amount of Euros 150.00 plus VAT equal to 22%;

FROM: the day following the closing date for entries
→ **TO:** publication of list of Competitors and cars accepted

The fee paid as a deposit by the Participant shall be entirely refunded to the said Participant, net of a penalty equal to 25% (VAT exempt pursuant to article 15, paragraph 1, Italian Presidential Decree 633/72);

FROM: the day following the publication of the list of Competitors and cars accepted
→ **TO:** Thursday 20th May

The entry fee shall be refunded to the extent of 50% plus VAT;

FROM: Friday 21st May

The entry fee shall not be refunded.

Withdrawal of a competitor for SPECIAL CASES (*)

Until 12th May

- A. Return of the **amount paid net of a deduction of € 150.00 plus VAT**.
- B. Transfer the fee paid to the next edition of the race, without prejudice to any economic integration in the event of an increase in the entry fee and without prejudice to the need to re-enter for the race.

FROM: Thursday 13th May → TO: Wednesday 26th May

The fee paid by the Competitor as a deposit shall be entirely refunded to the latter net of a deduction as administrative and management costs equal to 10% of the fee paid plus VAT at 22%;

FROM: Thursday 27th May → TO: Friday 4th June

The entry fee shall be refunded to the extent of 50% plus VAT;

FROM: Saturday 5th June

The entry fee shall not be refunded

(*) **SPECIAL CASES** include only people residing:

1. in countries that are blocked from entering Italy, by order of the Italian authorities or the country in relation to the COVID-19 health emergency;
2. in countries from which exit is blocked by order of the authorities of the same country in relation to the COVID-19 health emergency;
3. on Italian territory, in an area (e.g., Region, Province, Municipality) from which exit is blocked by order of the Italian authorities in relation to the COVID-19 health emergency;

For the purposes of the application of the provisions set forth in this article, person means alternatively:

- A. the competitor who is part of a Team;
- B. the owner (provided he is a natural person) of the vehicle if he is part of the crew;
- C. both the drivers indicated during the entry phase.

Cancellation or suspension of the event due to the Covid-19 pandemic and force majeure

FROM: opening date for entries → TO: closing date for entries

The fee paid as a deposit by the Competitor shall be entirely refunded to the latter;

FROM: The day following the closing date for entries → TO: Friday 7th May

The fee paid as a deposit by the Competitor shall be entirely refunded to the latter net of administrative charges in the amount of Euros 250.00 plus V.A.T. equal to 22%;

FROM: Saturday 8th May → TO: Wednesday 26th May

The fee paid as a deposit by the Competitor shall be entirely refunded to the latter net of a deduction as administrative and management costs equal to 10% of the fee paid plus VAT at 22%;

FROM: Thursday 27th May → TO: Friday 4th June

The fee paid as a deposit by the Competitor shall be entirely refunded to the latter net of a deduction as administrative and management costs equal to 20% of the fee paid plus VAT at 22%;

FROM: Saturday 5th June → TO: Sunday 13th June

The entry fee shall be refunded to the extent of 50% plus VAT equal to 22%;

FROM: Monday 14th June

The entry fee shall not be refunded.
