5. **ROUTE** (modification of SRR)

THE RACE ROUTE WILL HAVE A TOTAL DISTANCE OF KM 1.673,85 **978,18 + 687,32** AND WILL BE DESCRIBED IN THE ITINERARY, TIMES AND DISTANCE TABLE (ITDT) ALLEGATA AL PRESENTE RPG, DI CUI FA PARTE INTEGRANTE, ATTACHED TO AS WELL AS IN THE ROAD BOOK. THE ITDT WILL ALSO INDICATE THE TIME TRIALS AND AVERAGE TRIALS VALID FOR THE COMPILATION OF THE CLASSIFICATION. THE RACE DAYS WILL HAVE THE FOLLOWING DISTANCES:

- LEG 1: KM 228,05 + KM 95,00
- LEG 2: KM 227,31 + KM 225,00
- LEG 3: KM 253,04 + KM 260,00
- LEG 4: KM 269,78 + KM 107,32

10. RACE PROCEEDINGS

10.4.1 START OF AVERAGE TRIALS

MODIFICATION to the SRR of the 1000 MIGLIA 2022 race, to the SRR of the FERRARI TRIBUTE to 1000 MIGLIA 2022 race, to the SRR of the 1000 MIGLIA GREEN 2022 race, and to the SRR of the 1000 MIGLIA Experience 2022 race.

The PM/AT start will be **"open start".** Each PM/AT start will consist of two stations as shown in the RB, located **between 40 and 110 meters apart.**

The first station, manned by Marshals having the task of facilitating and regulating the departures of the cars, will be marked by **a yellow background sign, with flag in hand**. The Marshals in charge will not record on the Competitor Speed Chart the time of passage of the cars.

The second station, created to allow for the best accuracy of the timing function of the detection equipment (Tracking Equipment) by detecting the transit of the car already in motion, will not be manned by Marshals and will be indicated by a red background sign, with flag in hand.

The competitor, upon receiving a "green light" signal from the Route Marshals at the first location shall proceed immediately, without stopping, to the second location and take the actual start for PM/AT from the Zero Space/Zero Time line corresponding to that location. At that line, the competitor shall begin the space and time counting in order to meet the set average assigned for each Trial.

In order for the competitor to achieve the ideal average, there will be no counting in the first kilometer of the course of each Trial.

No complaint shall be allowed for any obstacles, difficulties or impediments that may arise in the course of the PM/AT: each competitor shall overcome them by his own means and with his own abilities, while respecting the rules of the Highway Code.

13. **CLASSIFICATIONS - COMPLAINTS - APPEALS** (modification of SRR).

13.1 CLASSIFICATIONS

The following classifications will be drawn up:

- a) An overall classification including all allowed cars;
- b) An overall classification among all the crews belonging to the Maybach Experience Grouping;
- c) An overall classification among all the crews not belonging to the Maybach Experience Grouping.

14. PRIZES (modifications to the SRR)

The race will feature the following honor prizes.

- Overall classification of Maybach Experience Grouping: prize for both drivers of the 1st classified crew.
- Overall classification of Experience Grouping: prize for both drivers of the 1st classified crew.

AVERAGE TRIALS

CHARECTERISTIC OF AVERAGE TRIALS

Among other things, the following special conditions of conduct will be complied with during the Average Trials:

- a) the expected number of readings for each PM/AT are indicated in the itinerary, Times and Distance Table;
- b) the averages for each PM/AT are indicated in the itinerary, Times and Distance Table;
- c) the reading will be done manually, to the second.



Departure Procedure

The individual departure time for the Average Trials is free and coincides with the passage of the front axle of the car over a pressure switch placed at the Start line of the PM/ATs themselves. The time will be duplicated manually by Race Officials appointed for the purpose.
