

MEDIA ACCREDITATION REGULATION COPPA DELLE ALPI

1. HOW TO REQUEST ACCREDITATION

Media accreditation requests must be submitted **only online**, by filling out the appropriate form, **starting from February 6 and no later than February 24, 2023**, after registering in the Press Area. Requests received by other means will not be considered. **On-site accreditation will not be possible.**

2. REQUIREMENTS AND CRITERIA

Only journalists with a valid professional card will be accredited.

Newspapers and print periodicals must be for sale to the public (trade and business magazines will not be accredited). Under no circumstances will advertising, public relations or corporate agencies be accredited as media.

Photographers and videographers are required to submit a chamber of commerce certificate or a letter of assignment formulated by the editor-in-chief of a newspaper registered with the court of territorial jurisdiction, attesting to their professional status.

Those who maintain a specialized blog that has been active for at least three months may apply for media accreditation as a blogger. In this case, the application, in addition to the submission of the chamber of commerce certificate or letter of assignment, must be accompanied by the submission of the editorial project. It is specified that the letter of assignment must mandatorily contain the following information:

- a. name and surname of the person in charge who will follow the event;
- b. task of the person in charge;
- c. information about the publication;
- d. e-mail address to which notifications should be sent;
- e. signature of the editor in charge.

Media accreditation requests for third parties or multiple requests will not be possible. Media accreditation, which we remind you is strictly personal, is issued only to those over 18 years of age.

3. ONLINE PROCEDURE

To apply for press accreditation, you must complete the following steps:

1. **Press Area Registration.** Registration can be done by accessing the following link: <https://login.1000miglia.it/login.php#press>. The data provided will be stored simplifying the submission of accreditation requests. The accreditation service is free of charge and is reserved for media operators. A confirmation e-mail will be sent to the specified e-mail address.
2. **Account Activation.** Registration to the portal must be activated by the user by clicking on the link provided in the automatic notification email. Registration for the accreditation service will have to be done only once.
3. **Completion of accreditation request form.** In order to apply for accreditation, it will be necessary to log into the system with the e-mail and password indicated when registering for the portal. The user will then have to select the event of his/her interest and upload the required documentation to the portal.
4. **Confirmation of receipt of the accreditation request.**

Acceptance of the accreditation request is entirely at the discretion of the 1000 Miglia S.r.l. Press Office. Requests that are incomplete, do not meet the requirements or are received after the specified deadline will

not be accepted. Notification of the outcome of the request will be made by email to the address provided during registration on the portal.

4. DISCLAIMER

By making the request for accreditation, you declare:

1. to be aware of the dangers inherent in the context of motorsports events and in assisting in their conduct. You further certify that you have the experience and professional training to safely witness the conduct of the event, that you will engage in all necessary caution to avoid physical and material harm to yourself and others;
2. to be aware that the event is being held on roadways open to traffic, consequently undertaking to observe all current road traffic regulations on the territories affected by the transit of the Event;
3. to know and accept that it is absolutely forbidden to take (i) alcohol, from 6 (six) hours before the start of each leg and until the finish of each leg; and (ii) drugs and/or substances suitable to alter psycho-physical conditions;
4. to comply at all times with: i) the instructions provided by the Organizer and to conform his/her conduct to such instructions, ii) the safety orders and instructions provided by the Race Officials and the Police Forces;
5. to assume any and all responsibility for damages he/she may suffer, due to his/her own carelessness or inexperience;
6. to relieve 1000 Miglia S.r.l., the Clerk of the Course and any other person, Institution or Association from any and all responsibility for the above mentioned;
7. to relieve ACI SPORT, 1000 Miglia S.r.l., all persons in charge of the organization of the Race, the ACIs however involved in the race, the Race Officials and the owners of the routes where the Race takes place from any and all responsibility regarding any damage occurring to the pass user or produced or caused by third parties or things to the pass user;
8. to be aware that the accreditation and consequently the provided pass are strictly personal and to be aware that it is strictly forbidden to give it to third parties;
9. to comply with all regulations issued in any capacity in relation to public health and safety including with regard to the prevention of the spread of COVID-19.

Any abuse will result in the immediate withdrawal of any assigned pass and car sticker, will prevent the issuance of both for subsequent years and will, in case, be reported to the competent judicial authorities. Please note that the pass and car sticker remain the property of the Organizer who may withdraw them at any time.

5. IMPORTANT NOTE

The sale of photographs and videos taken during the Race directly to competitors, drivers and related staff is prohibited, unless expressly authorized by 1000 Miglia S.r.l..

6. PROCESSING OF PERSONAL DATA

The processing of personal data collected during the media accreditation procedures will take place in accordance with EU Regulation No. 2016/679 (so-called GDPR) and Legislative Decree No. 196/2003 as amended by Legislative Decree No. 101/2018.
