

## 1000 MIGLIA 2023 MEDIA ACCREDITATION REGULATION

### 1 HOW TO REQUEST ACCREDITATION

Requests for accreditation to the 2023 edition of the 1000 Miglia ("the Event") shall be submitted **exclusively online**, according to the procedure described in these Regulations, **starting from 20<sup>th</sup> April and up to 21<sup>st</sup> May 2023**.

Accreditation shall be valid only upon confirmation by the Press Office of 1000 Miglia S.r.l. and **will be confirmed by Tuesday 30<sup>th</sup> May**.

Requests received by other means will not be taken into consideration. Accreditation will not be possible on site.

### 2 REQUIREMENTS AND CRITERIA

Only journalists in possession of a valid professional card will be accredited.

Newspapers and printed periodicals must be on sale to the public (trade and business magazines will not be accredited). Under no circumstances will advertising, public relations or corporate agencies be accredited as media.

Photographers and videographers are required to submit a chamber of commerce certificate or a letter of assignment issued by the editor-in-chief of a newspaper registered with the court of jurisdiction, attesting to their professional status.

Those who maintain a specialised blog that has been active for at least three months may apply for Media accreditation as a blogger. In this case, in addition to submitting the chamber of commerce certificate or letter of assignment, the application must be accompanied by the presentation of the editorial project.

Please note that the letter of assignment must contain the following information:

- a. name and surname of the person appointed to follow the event;
- b. task of the appointed person;
- c. information on the publication;
- d. e-mail address to which correspondence should be sent;
- e. signature of the editor in charge.

It will not be possible to make media accreditation requests for third parties or multiple requests, and the accreditation must be

collected personally by the applicant. Media accreditation is also only issued to persons over the age of 18.

### 3 ONLINE PROCEDURE

To apply for a Media accreditation, you need to register on the dedicated portal by connecting to the [link](#); filling in the necessary fields and uploading the required documents.

The accreditation service is free of charge and is reserved for media operators. An email confirming that the application has been accepted will be sent to the specified email address.

All updates, video material, photos, press releases and news related to the race will be available on the Press Area of the [1000miglia.it](http://1000miglia.it) website.

Applications that are incomplete, do not meet the requirements or arrive after the deadline will not be accepted. Notification of the outcome of the request will be sent by email to the address provided during registration on the portal. We recommend that you also check your junk mail folder for receipt.

Together with the personal pass, it is possible to request the issue of a car sticker that allows you to follow the event with your own vehicle inside the 1000 Miglia convoy. The allocation of the personal pass and of the car sticker is at the sole discretion of the 1000 Miglia Press Office and is subject to the requirements and criteria indicated in paragraph 2.

### 4 PROVISIONS CONCERNING ACCESS TO THE EVENT AREAS

By applying for accreditation, you declare:

- 1. to be aware that it is forbidden to affix the Media sticker on vintage cars, classic cars or cars which can be identified as such**, and to be aware that failure to comply with this instruction will result in the immediate withdrawal of the car sticker and personal pass. The affixing of the sticker shall be carried out by the 1000 Miglia staff and under no circumstances will stickers be handed out to be affixed independently. The sticker may only be affixed on the

car indicated during the accreditation request, i.e. the same car that will be used to follow the race. Any substitution of the car indicated on the application must be promptly notified at the time of accreditation;

2. to be aware of the dangers inherent in motor sport events and in attending them. The applicant hereby certifies to have the experience and professional training to attend the event in safety and that undertakes all necessary precautions to avoid physical and material damage to himself/herself and others;
3. to be aware that the event is being held on roads open to traffic, and consequently undertakes to observe all the traffic rules laid down in the Italian Highway Code;
4. to comply at all times with:
  - i) the indications provided by 1000 Miglia and to conform one's conduct to such indications;
  - ii) the safety orders and instructions given by the Race Officials and the Police
5. assuming any and all responsibility for any damage he/she may suffer as a result of his/her imprudence or inexperience;
6. releasing 1000 Miglia, the Clerk of the Course and any other person, Institution or Association from any and all liability in respect of the above;
7. releasing 1000 Miglia S.r.l. and all persons and companies involved in the organisation of the race, the ACI (Italian Automobile Clubs Associations) involved in the race, the Race Officials and the owners of the routes where the race takes place from any liability regarding any damage occurred to the pass-user or produced or caused by third parties or things to the pass-user;
8. being aware that the accreditation and consequently any pass provided is strictly personal and in the name of the applicant and being aware that it is strictly forbidden to pass it on to third parties;
9. abiding by all regulations issued for any reason in relation to public health and safety, also with regard to the prevention of the spread of COVID-19.

Any abuse will result in the immediate withdrawal of any pass and car sticker issued, will prevent the issue of both for subsequent years and will, if appropriate, be reported to the competent judicial authorities. Please note that the pass and the car sticker remain the property of the organiser who may withdraw them at any time.

In relation to the use of the images the following is also declared:

1. To release 1000 Miglia S.r.l. from liability from any possible claim made by third parties concerning the above mentioned photos and/or audio-video recordings.

## **5 PROCESSING OF PERSONAL DATA**

Personal data collected during the accreditation procedures will be processed in accordance with EU Regulation no. 2016/679 (so-called GDPR) and with Legislative Decree no. 196/2003 as amended by Legislative Decree no. 101/2018.
