**Public notice to receive expressions of interest for the use of the trademarks "1000 Miglia Warm Up Austria" and "1000 Miglia Experience Austria" as well as the related domains in the territory of Austria**

**1. OBJECT**

The company 1000 Miglia Srl, wholly owned by the Automobile Club of Brescia, intends to acquire applications for participation in procedure for the exclusive use of:

- the verbal and figurative trademarks "1000 Miglia Warm Up Austria" and "1000 Miglia Experience Austria"
- the domains in their extension "millemigliawarmupaustria.at" and "1000migliawarmupaustria.at" and, in case of use of the trademark 1000 Miglia Experience as as detailed below, "1000migliaexperienceaustria.at and "millemiglaexperienceaustria.at"

The exclusive use of the aforementioned trademark and domains refers only to product class 41 in relation to the service for organizing motor sport events in the territory of Austria.

These events must be carried out by the successful bidder according to the indications, directives and requirements defined by 1000 Miglia which will be explained in the technical specifications attached to the invitation letter. The period of the organization of the events must be in any case approved by 1000 Miglia.

The technical specifications and additional tender documents will be made available together with the letter of invitation that will be sent to suitable economic operators who have submitted the application form in reply to this notice according to the terms and conditions set out below.

**1.1 SUB-LICENSING EVENT DETAILS**

The sub-licence provides for the organisation of the 1000 Miglia Warm Up event for the first year of the contract, which shall include a maximum number of 35 cars entered and a maximum of 3 event days in total.

As from the second year, the successful applicant may alternatively:

- a) Continue with the organisation of the 1000 Miglia Warm Up event;
- b) organise the 1000 Miglia Experience event in place of the 1000 Miglia Warm Up event with a maximum number of 75 cars entered for the first edition and 100 for the further editions, in any case with a maximum of 6 event days in total. The winning applicant shall in any case be entitled, following the organisation of the 1000 Miglia Experience and in its place, to stage the 1000 Miglia Warm Up event again.

**2. REQUIREMENTS FOR PARTICIPATION**

The requirements for participation in the procedure are as follows:

- A) **general requirements:** non-existence of any cause for exclusion provided for by artt. 94, 95, 98 of the Italian D.Lgs. n. 36/2023;
- B) **professional suitability requirements:** registered office or operational headquarters for activities related to the subject of this procedure.

### 3. TOTAL AMOUNT AND CHARGES OF THE WINNER OF THE PROCEDURE

The winner of this procedure shall pay 1000 Miglia:

- a) for the organisation of the 1000 Miglia Warm Up event for each edition:
  - i. € 20,000.00 (twenty thousand/00) plus VAT for the organisation of the first edition and, in case of non-conversion with the 1000 Miglia Experience event, for the second edition;
  - ii. € 30,000.00 (thirty thousand/00) for each edition starting from the third one.
  - iii. In addition to the fees mentioned in the two previous points, € 5,000.00 (five thousand/00) plus VAT for the consultancy services provided by 1000 Miglia. Travelling, board and lodging expenses for 1000 Miglia personnel will also be borne by the successful bidder, as provided for in the technical specifications;
  - iv. a percentage equal to 2% (two percent), or any higher percentage offered in the tender, of the turnover of each event;
  - v. 2 free entry fees (not to be included in the maximum number of 35 crews).
- b) In case of organisation of the 1000 Miglia Experience event for each edition:
  - i. € 50,000.00 (fifty thousand/00) plus VAT for the organisation of the first edition;
  - ii. € 75,000.00 (seventy-five thousand/00) plus VAT for each edition starting from the second;
  - iii. In addition to the fees mentioned in the two previous points, € 5,000.00 (five thousand/00) plus VAT for the consultancy services provided by 1000 Miglia;
  - iv. a percentage equal to 2% (two percent), or any higher percentage offered in the tender, of the turnover of each event.
  - v. 5 free entry fees (not to be included in the maximum number of crews).

### 4. DURATION

The duration of the exclusive use under the terms of this agreement is for 02 (two) editions with the possibility of renewal, subject to agreement between the parties, within three months of the end of the contract, for a further 03 (three) editions.

The first edition of the event shall be held during 2024.

### 5. AWARDING CRITERIA

The procedure will be awarded, even should there be only one formally valid offer, as long as it is deemed convenient and appropriate by 1000 Miglia S.r.l., through the criterion of the most economically advantageous offer pursuant to art. 108 of Legislative Decree 36/2023.

The awarding of the score for the technical offer, set at a maximum of **80 points** in total, will be based on the evaluation criteria and relative scores that will be indicated in the letter of invitation.

A maximum of **20 points** shall be attributed to the economic offer, which shall be awarded according to the increase presented with respect to the tender base equal to the percentage of 2% (two percent) excluding tax on the turnover deriving from the organisation of the event.

### 6. METHOD OF CONDUCTING THE PROCEDURE AND PRESENTATION OF THE OFFER

- 1) Application to participate drawn up on letterheads according to the attached format in Italian or English.
- 2) Identity card issued by the Italian authorities or passport of the undersigned of the application;
- 3) Chamber of Commerce company registration of the competitor(s). Please note that this document, if in a language other than Italian, must be submitted accompanied by an Italian translation that is compliant with the original text and certified by the Italian diplomatic or consular authorities of the country in which it was drawn up, or by an official translator.
