

MEDIA ACCREDITATION REGULATIONS COPPA DELLE ALPI 2024

1. HOW TO APPLY FOR ACCREDITATION

Media accreditation applications must be submitted **exclusively online**, by filling in the appropriate form, **from 13 February until 18 March 2024**, after registering in the [Press Area](#). Applications received by other means will not be considered. **It will not be possible to accredit directly on site.**

2. REQUIREMENTS AND CRITERIA

Only **journalists** in possession of a valid professional card or a letter of assignment issued by the editor-in-chief of a newspaper registered with the court of jurisdiction will be accredited.

Newspapers and printed periodicals must be on sale to the public (trade and business magazines will not be accredited). Under no circumstances will advertising, public relations or corporate agencies be accredited as media.

Photographers and video operators are required to submit a chamber of commerce certificate or a letter of assignment issued by the editor-in-chief of a newspaper registered with the court of jurisdiction, attesting to their professional status.

Media accreditation as **content creator** may be applied for by those who have been maintaining a specialised blog that has been active for at least three months. In this case, the application must be accompanied by the presentation of the editorial project, in addition to the chamber of commerce certificate or letter of appointment.

It is to be specified that the assignment letter must contain the following information:

- a. name and surname of the person appointed to follow the event;
- b. task of the person appointed;
- c. information on the publication;
- d. e-mail address to which correspondence should be sent;
- e. signature of the editor.

It will not be possible to make media accreditation applications for third parties or multiple requests. Media accreditation, which we would like to remind you is strictly personal, is only issued to persons over the age of 18.

3. ONLINE PROCEDURE

To apply for press accreditation, you must complete the following steps:

1. **Registration to the [Press Area](#).** Registration can be done by accessing the following link: <https://login.1000miglia.it/login.php>. The data provided will be stored, simplifying the submission of the accreditation application. A confirmation e-mail will be sent to the specified e-mail address.
2. **Account activation.** Registration on the portal must be activated by the user by clicking on the link in the automatic notification e-mail. Registration only needs be carried out once.
3. **Completing the accreditation application form.** In order to apply for accreditation, it will be necessary to access the system with the e-mail and password indicated when registering on the portal. The user must then select the "Accreditation Application" area and enter the required information and documentation. The accreditation service is free of charge and is reserved for media operators.
4. **Confirmation of receipt of the accreditation application.** An e-mail confirming the request will be sent to the specified e-mail address.

Acceptance of the accreditation application is entirely at the discretion of the 1000 Miglia S.r.l. Press Office. Applications that are incomplete, do not comply with the requirements or are received after the specified deadline will not be accepted. Notification of the outcome of the application will be sent by email to the address provided during registration on the portal, **by Thursday 28 March 2024**.

4. DISCLAIMER

By applying for accreditation, you declare:

1. to be aware of the dangers inherent in motor sport events and in attending them. You also hereby certify to have the experience and professional training to attend the event in safety, to undertake to take all necessary precautions to avoid physical and material damage to yourself and to others;
2. to be aware that the event is being held on roads open to traffic, and consequently undertake to comply with all current road traffic regulations in the areas affected by the transit of the Event;
3. to know and accept that it is absolutely forbidden to take (i) alcohol, from 6 (six) hours before the start of each leg and until the finish of each leg; and (ii) drugs and/or substances likely to alter psycho-physical conditions;
4. to comply at all times with: i) the instructions given by the Organiser and to conform your conduct to those instructions, ii) the safety orders and instructions given by the Race Officials and the Police Force;
5. to assume any and all liability for damage you may suffer as a result of your own recklessness or inexperience;
6. to release 1000 Miglia S.r.l., the Clerk of the Course and any other person, Institution or Association from any and all liability in respect of the foregoing;
7. to release ACI SPORT, 1000 Miglia S.r.l., all the people in charge of the organisation of the race, the ACIs in any case involved in the race, the Race Officials and the owners of the routes where the race takes place from any liability regarding any damage occurring to the pass user or produced or caused by third parties or things to the pass user;
8. to be aware that the accreditation and consequently any pass provided is strictly personal and to be aware that it is strictly forbidden to pass it on to third parties;
9. **to be aware of the ban on affixing the Media sticker on vintage cars, classic cars or cars that can be mistaken for such**, and to be aware that failure to comply with this

instruction will result in the immediate withdrawal of the car's sticker and your personal pass;

10. to comply with all regulations issued in any capacity in relation to public health and safety, including with regard to preventing the spread of COVID-19.

Any abuse will result in the immediate withdrawal of any pass and car sticker issued, will prevent the issue of both for subsequent years and will, if appropriate, be reported to the competent judicial authorities. Please note that pass and car sticker remain the property of the Organiser who may withdraw them at any time.

5. IMPORTANT NOTE

The sale of photographs and videos taken during the race directly to competitors, drivers and their staff is prohibited, unless expressly authorised by 1000 Miglia S.r.l.

6. PROCESSING OF PERSONAL DATA

The processing of personal data collected during the media accreditation procedures will take place in accordance with EU Regulation No. 2016/679 (so-called GDPR) and Legislative Decree No. 196/2003 as amended by Legislative Decree No. 101/2018.
