## **Withdrawal of a Competitor Application**

**FROM: Opening date of entries → TO: Closing date of entries**

The fee paid as deposit by the Competitor shall be entirely refunded to the latter, net of administrative charges in the amount of **Euros 150.00** plus VAT equal to 22%.

**FROM: The day following the closing date for entries → TO: Competitors and accepted cars publication**

The fee paid as a deposit by the Participant shall be entirely refunded to the said Participant, net of a **penalty equal to € 1000** (VAT exempt pursuant to article 15, paragraph 1, Italian Presidential Decree 633/72).

**FROM: Friday 24<sup>th</sup> May 2024 → TO: Thursday 30<sup>th</sup> May 2024**

The fee paid as a deposit by the Participant shall be entirely refunded to the said Participant, net of a **penalty equal to 75%** plus VAT 22%.

**FROM: Friday 31<sup>st</sup> May 2024**

The entry fee shall **not be refunded**.

## Cancellation or suspension of the event due to force majeure

FROM: Opening date of entries → TO: Closing date of entries

The fee paid as a deposit by the Competitor shall be **entirely refunded** to the latter.
