

REFUND POLICY

- → Accepted cars publication by 13th May 2024.

Withdrawal of a Competitor Application

FROM: Opening date of entries \rightarrow TO: Closing date of entries

The fee paid as deposit by the Competitor shall be entirely refunded to the latter, net of administrative charges in the amount of **Euros 150.00** plus VAT equal to 22%.

FROM: The day following the closing date for entries \rightarrow TO: Competitors and accepted cars publication

The fee paid as a deposit by the Participant shall be entirely refunded to the said Participant, net of a **penalty equal to € 1000** (VAT exempt pursuant to article 15, paragraph 1, Italian Presidential Decree 633/72).

FROM: Competitors and accepted cars publication \rightarrow TO: Thursday 23rd May 2024

The fee paid as a deposit by the Participant shall be entirely refunded to the said Participant, net of a penalty equal to 50% plus VAT 22%.

FROM: Friday 24th May 2024 \rightarrow TO: Thursday 30th May 2024

The fee paid as a deposit by the Participant shall be entirely refunded to the said Participant, net of a penalty equal to 75% plus VAT 22%.

FROM: Friday 31st May 2024

The entry fee shall not be refunded.







Cancellation or suspension of the event due to force mejeure

FROM: Opening date of entries \rightarrow TO: Closing date of entries

The fee paid as a deposit by the Competitor shall be entirely refunded to the latter.

FROM: The day following the closing date of entries \rightarrow TO: Thursday 23rd May 2024

The fee paid as a deposit by the Competitor shall be entirely refunded to the latter net of a **deduction** as administrative and management costs **equal to 10%** of the fee paid plus VAT at 22%.

FROM: Friday 24th May 2024 \rightarrow TO: Thursday 30th May 2024

The fee paid as a deposit by the Competitor shall be entirely refunded to the latter net of a **deduction** as administrative and management costs **equal to 20%** of the fee paid plus VAT at 22%.

FROM: Friday 31^{st} May $2024 \rightarrow TO$: Saturday 8^{th} June 2024

The fee paid as a deposit by the Competitor shall be entirely refunded to the latter net of a **deduction** as administrative and management costs **equal to 50%** of the fee paid plus VAT at 22%.

FROM: Sunday 9th June 2024
